NOTICE is hereby given by the Board of County Commissioners of Douglas County requesting Statements of Qualifications for qualified Consultant Services to review and update the Douglas County Hazard Mitigation Comprehensive Plan. Services to include for a one year consulting period beginning March 1, 2018 ending January 31, 2019.

Douglas County is currently seeking qualifications from competent experienced consultants to update the Douglas County Hazard Mitigation Plan that meets all requirements under 44 CFR Part 201.6. As described in the Federal Register (Volume 67, Numbers 38 and 109, dated February 26, 2002 and October 2002 respectively), Section 322 of the Disaster Mitigation Act of 2000 requires that all local governments adopt an approved All-Hazard Mitigation Plan to be eligible to receive future hazard mitigation grant funding.




