THIS MATTER having come on regularly for hearing this day on the Petition to Restore Right to Possess Firearm, pursuant to RCW 9.41.040(4), the Court having reviewed the certified copies of criminal history attached to the Petition, having heard the testimony of Petitioner, the Prosecuting Attorney's office having approved entry of this Order, and being fully advised in the premises, the Court finds that the Petitioner is entitled to the restoration of Petitioner's right to possess a firearm under RCW 9.41.040(4), and it is now

ORDERED, ADJUDGED AND DECREED that the Petitioner be and is hereby granted a Certificate, pursuant to RCW 9.41.040(4), and the Petitioner's right to possess a firearm which had been impaired by Petitioner's prior criminal convictions is hereby restored.

**WARNINGS**

THIS ORDER AND CERTIFICATE ONLY RESTORES YOUR RIGHT TO POSSESS A FIREARM UNDER WASHINGTON LAW.
