The Douglas County Board of Commissioners will conduct a public meeting to consider limited amendments to the Douglas County Shoreline Master Program during their Tuesday, September 29, 2020 regular session at 11:15 AM. The meeting will be in the Hearing Room at the Douglas County Public Services Building, 140 19<sup>th</sup> Street NW, East Wenatchee, WA. The planning commission has recommended approval of the amendments. A Determination of Non-significance has been issued for the proposals in accordance with the State Environmental Policy Act.

The Washington State Department of Ecology has issued a statement of initial concurrence of the proposed limited amendments.

The Board of Commissioners will be accepting public testimony on the proposal in order to make a decision on whether to adopt the amendments. The Board will take action to accept the recommendation, continue the public meeting to another date and time, or reject the recommendation and set a public hearing to consider revisions to the recommendation. Written comment is encouraged as the Board may limit presentations to three minutes per speaker in order to accommodate all persons that wish to enter evidence into the record. 


